**1. I CERTIFY** that this consignment does not contain the following forbidden items:

- Recalled, damaged or defective cells and battery packs;
- Shipments containing only cells or battery packs;
- Used or refurbished electronics containing lithium or sodium ion or lithium metal batteries packaged in an overpack.

Shipments containing lithium or sodium ion, or lithium metal batteries subject to the marking requirements of Section II of Packing Instruction 966, 967, 969, 970, 977 or 978 will require this declaration to be completed and submitted upon tender.

Lithium ion cells and batteries must be offered for transport with a state of charge NOT exceeding 30% of their rated capacity or with an indicated battery capacity of NOT more than 25%.

**4. I UNDERSTAND THAT EACH INDIVIDUAL PACKAGE (whether or not it's contained within an overpack):**

- MUST NOT contain more than 5 kg of cells or battery packs.
- Must be properly identified with a battery mark.

**I declare that the contents of this consignment have been properly prepared, and are packaged, marked, and labeled correctly, and are in all respects in proper condition for transport. All regulatory requirements have been met.**
